He is a wonderful guy, and I have a feeling that his NAACP job is not going to last forever, for the NAACP is not going to last forever, at least not as an effective organization. Moreover, if he had an alternative job offer he could ask more support from the NAACP.

I hadn't heard about Travis being shot. I heard a rumor in Durham that someone had been shot, and I received a letter and news release from SNCC saying ~~in~~ the letter that I would read about the shooting in the news release, but not saying in the news release much at all about the shooting. I don't think the Miss. Free Press gave it much of a play at all, if anything. Publicity is the only protection people like Travis have. I know you're doing what you can. Don't waste time writing to me the details. Publicize.
