This is an attempt to open the old racist secret police files of the Mississippi State Sovereignity Commission, 1955-1971, on a basis similar to the way Federal files and others are handled, giving privacy protection to individual

citizen-victims. The local press (controlled by Gannet of USA Today) is represented by the local (not National) ACLU which claims "freedom of the press" supercedes individual privacy rights and that private citizens have no more rights than public officials who illegally spied on and created files on private citizens. This is currently back in the U.S. District Court in Mississippi for clarification and implementation although we did win a unanimous ruling earlier from the U.S. Fifth Circuit Court of Appeal ordering privacy rights protected.

CURRICULUM VITAE

Rev. Edwin King: Church Work, Summary

I am an ordained minister of the United Methodist Church and a member of the Mississippi Annual Conference. I serve under my bishop in "special appointment" to college teaching with the University of Mississippi Medical Center and part time teaching in the Religion Department of Millsaps College. With the University Medical Center I am an associate professor in the Department of Interdisciplinary Studies of the School of Health Related Professions. I teach courses in sociology of health care, communications with patients and families, medical ethics, death and dying, etc. I am also the counselor for students in this school.

I have been with the University of Mississippi Medical Center since fall of 1974

From 1970 to 1972 I was with the Methodist Board of Missions (now Global Ministries) serving in India (in special research as well as presenting lectures, sermons, etc.) and with the New York board office back in the U.S. teaching in mission school classes in all parts of the U.S. In 1979 I was a member of a mission study trip sponsored by the Board of Global Ministries to China (with focus on former mission hospitals and medical schools now run by government) and to India.

In 1972 I was the guest of the British Methodist Church for a series of sermons and lectures on American race relations to groups in England and for the World Council of Churches for sermons and lectures in Switzerland, Germany, and the Netherlands.

Prior to my work in India I worked for the Delta Ministry of the National Council of Churches and the World Council of Churches in race relations work, particularly school desegregation efforts, in Mississippi.

I was a member of the Mississippi Conference of the Former Central Jurisdiction of the United Methodist Church until the present merged church structure was created.

I served as college chaplain of Tougaloo College from Jan., 1963 to Sept., 1967.

Early in my ministry I served as assistant pastor of a local church in Cambridge, MA and pastor of small churches in Massachusetts, Montana, and Mississippi.

My seminary training was at Boston University School of Theology where I studied from 1958 to 1963. I received the M. Divinity degree in 1961 and the M. of Sacred Theology degree in 1963. My concentrations were in sociology of religion, social ethics, and pastoral counseling. I did additional study in sociology of religion and social ethics as a Merrill Fellow at Harvard Divinity School in 1966.
